

**TRADE IN TERMS AND CONDITIONS**

1. Vendzone trade-in program is currently available in metro areas only in Melbourne, Sydney, Brisbane, Adelaide and Perth only.
2. Credit value of your old / trade-in vending machine will be determined solely based on Vendzone's discretion
3. By agreeing to enter into this program you warrant that:
  - a. The information you provided is true and accurate.
  - b. The vending machine you are transferring to Vendzone is your property
  - c. You have emptied, unplugged and defrosted the machine, drained any water from inside the machine and in any drip trays below the machine and provided safe access to the authorised person collecting the vending machine.
  - d. It is your responsibility to make the vending machine accessible for the removalists to collect. If the removalists cannot access the vending machine a re-booking and transport will be charged and will have to be paid before next collection attempt.
  - e. You acknowledge that, at their discretion, the authorised person collecting the vending machine may decline to collect the machine if they feel that conditions are unsafe, that removal may cause damage to property, that removal is infeasible or that the vending machine is ineligible under the Vendzone trade in program. In such a situation, you will not be eligible for the trade-in credit for that equipment.
  - f. If leaving the vending machine outside for collection in your absence, you are leaving the machine wholly within the boundaries of your property and you have made the fridge/freezer safe so that no child can get inside by either removing the doors or using industrial-grade tape or rope to secure the machine doors shut.
  - g. You acknowledge that Vendzone does not assume any responsibility for theft of vending machine left outside for collection.
  - h. **Vending Machine removals involving 1 (one) or more stairs will incur a fee which will be negotiated directly with the removalists prior to collection.**
  - i. You agree to the conditions set out herewith.
  - j. All set of Keys, manuals, any removed accessories or parts must be left inside the drop box or inside of the machine prior to pick up. Keys must be left in the drop box or coin return cup.
  - k. Note reader, coin changer and stock must be removed from the machine prior to pick up.
4. Upon Vendzone having: (a) received confirmation from the removalist that your vending machine has been collected; (b) received the completed paperwork from the removalist, including a copy of this form completed and signed by you; and (c) processed such paperwork, (d) received full payment as per the invoice, Vendzone will then release new machine.
5. **Limit of Liability:** You agree that, to the fullest extent permitted by law, Vendzone (including its officers, employees, agents, contractors and volunteers) shall not be liable for any property damage or personal injury arising out of the collection of the appliance other than in the event of gross negligence or wilful misconduct on the part of Vendzone
6. **Privacy Notice:** Vendzone is collecting personal information about you, including your name, address, and contact details for the purpose of administering the Trade-in program. In addition, by agreeing to these terms and conditions, that we may use this information to send vending news from time to time. Your details will not be provided to any other party for marketing or other purposes, unless required by law. Vendzone is committed to safeguarding and protecting the privacy of your personal information, and adheres to the Australian National Privacy Principles.
